CDA will focus on partnerships and relationship building with indigenous people and their communities and focus on the College mandate and what its reach is as it relates to building reconciliation. Registration Renewal 2021/2022 Completed

As we entered a new registration year, the College had 1,307 regulated members renew their registration. The College also had 8 regulated members on the Temporary Register for a total of 1,315 regulated members as of April 1, 2021.

Practice permits and official tax receipts are available on the <u>Login for Regulated Members</u> under "Download Registration". The College archives previous year's permits and receipts.

- Regulated members are encouraged to have their practice permit available for inspection
 when requested by employers and the public, as required under the *Health Professions*Act. Employers and the public can also verify registration by accessing the Public Register
 of the College at https://cdav6.alinityapp.com/Client/PublicDirectory
- Official tax receipts include the breakdown of practice permit fees to include GST paid.

CCP Review Audit & Document Audit

During Registration Renewal, Continuing Competence Program (CCP) submissions were completed by all regulated members for 2020/2021. The College is completing the CCP Review Audit and Document Audit process for 2021 but wishes to provide all regulated members with some important information on updates to the audit process.

- A review audit is an internal College process of ensuring regulated members' reflections
 match and are appropriate to their set learning goals. Every year, the College randomly
 selects one third of regulated member submissions for review audit.
 - NEW: For any regulated members part of the competence sample for the current Review Audit, you will see this selection noted in your <u>Login for Regulated</u> <u>Members</u> under "My Audits". Please note, no action is required from you unless you are contacted by the College.
- A document audit includes a request from the College to submit CCP Workbook materials
 in addition to documentation/verification of completed learning activities. The College
 randomly selects 10% of all reviewed programs for a document audit review, which
 includes a review of submitted documentation along with online CCP submissions.
 - NEW: For any regulated members selected for Document Audit, in addition to having a record noted in your "My Audits" section online, you would also have received an email in early May requesting the required documentation. The College will now communicate by email rather than letter mail when requesting audit documentation.
 - NEW: Should you be selected for a document audit, you will be required to submit materials to the College electronically. Therefore, as you complete your competence learning each year, you may wish to compile and save your learning verifications digitally to allow for easy submission when requested.
- You are required to retain all CCP documentation for three years, should you be asked to submit these materials to the College for review at any time. It is therefore essential that you keep accurate and complete records.

Under the *Health Professions Act*, all regulated health colleges are required to have a Continuing Competence Program in place. It is the legislated mandate of the College to ensure regulated members maintain their professional competence related to practice. It is the

professional responsibility of every regulated member to ensure that they are completing their CCP each year and are maintaining complete and accurate records.

Canadian Dietetic Registration Examination (CDRE)

May 2021 Sitting of the CDRE

For all candidates who wrote the May 2021 sitting of the Canadian Dietetic Registration Examination (CDRE), the College provided results on June 23, 2021.

November 2021 Sitting of the CDRE

This is a notice to all candidates for the November 22-23, 2021 sitting of the Canadian Dietetic Registration Examination (CDRE), the Alliance of Canadian Dietetic Regulatory Bodies (the body that administers the national CDRE) will continue to offer the CDRE through online, remote proctoring with ProctorU.

The CDRE Fee is \$600.00 (no GST). Payment of the exam fee must be received before a candidate is pre-registered for the November 2021 CDRE.

The exam will be accessible from a candidate's personal computer in a quiet setting. A webcam, speakers and stable live Internet connection are required. Candidates should review ProctorU's technology requirements here (https://www.proctoru.com/proctoru-live-resource-center#what). Once scheduled for the CDRE, candidates will be able to log-on to an account with ProctorU to test their technology's ability to connect with the online remote proctor system.

All candidates will receive information via emails from the College office on scheduling the exam as well as links to helpful resources.

Making sure you receive CDA emails

The College office primarily communicates with regulated members through email and through information provided on the College website. To ensure that you are receiving all important communications from the College office in a timely manner, please ensure that you have added CDA Administration (office@collegeofdietitians.ab.ca) to your safe sender list or address book.

You may be able to complete this process on your own through your email account or, should you have an email address tied to an organization, you may need to contact your I.T. department to ask them to put the College email on your "whitelist", "safe" or permitted email sender list.

What is a "Whitelist" or "Safe Senders List"?

Adding our sending domain (collegeofdietitians.ab.ca) to your list of accepted email senders (often referred to as a "whitelist", "safe list", or "list of privileged senders") will ensure that you receive College communications from all College email addresses.

Failure to receive emails from the College does not excuse missed deadlines or requirements for maintaining your registration.

Ensuring your Profile is Current

The College reminds all Dietitians that as regulated professionals, you have a duty to update your profile within 30 days of any change in the information required for the College's Register. This includes changes to your legal name, contact information (phone and email), mailing address, and employment information. You may update your profile information online by logging onto the Login for Regulated Members to complete a Profile Update.
