## **Registration Renewal 2024/2025 Complete**

As we enter a new registration year, the College of Dietitians of Alberta (the College) had 1,351 regulated members renew their registration on the General Register. The College also had 4 regulated members on the Temporary Register for a total of 1,355 regulated members as of April 1, 2024.

Practice permits and official tax receipts are available on the <u>Registrant Portal</u> under "Download Registration". The College archives previous year's permits and receipts.

- Regulated members are required under the *Health Professions Act* to have their practice permit available when requested by employers and the public. Employers and the public can also verify registration by accessing the Public Register of the College at <u>https://cda.alinityapp.com/Client/PublicDirectory</u>
- Official tax receipts include the breakdown of practice permit fees to include GST paid.

The College received renewal feedback from only a handful of regulated members. The College continues to have resources available in several formats for regulated members to refer to when completing any process throughout the year. For Dietitians – Registration Renewal – Important Resources for Renewal and CCP.

# Scope of Practice Survey Update

The College supports Dietitians working to their full level of competence. To this end, the College conducted a member survey earlier in the year with the purpose of determining: 1. if there are areas of practice/tasks that dietitians are performing or being asked to perform that traditionally may not be considered "within scope of practice"; and 2. to determine if those activities require amendments to our regulations.

The College thanks all registrants who provided their input and feedback. The College Council will review the information obtained from the survey which will inform a regulation amendment request to government that would impact dietitian practice in Alberta. We will keep members informed as this process moves forward.

The following is a summary of the most relevant survey findings:

- 254 members (17.5% of membership) responded to the survey. Of those who responded, 168 (68%) identified their area of practice as patient/client care (clinical, long-term care, primary care, etc.).
- 25% (64) of respondents reported they perform restricted activities.
- 21% (50) of respondents identified the following restricted activities most often (top 4) as one's dietitians should be performing (adding to scope of practice, above and beyond the College's current restricted activity list):
  - Ordering labs
  - Ordering/prescribing vitamins and minerals, IVs or other meds, and nutrition supplements, etc.
  - Prescribing insulin or anti-hyperglycemic agents
  - Inserting CGMs, insulin pump sets, etc.
- 78% (195) of respondents feel the definition of medical nutrition therapy is adequate; 90% (222) feel the definition of nutrition support is adequate.
- 55% (137) of respondents indicated that medication management is integral to the nutrition care of clients, identifying the following medication categories of greatest relevance (top 3):
  - Anti-hyperglycemic agents, insulin
  - Vitamins and minerals
  - o GI meds including pancreatic enzymes, anti-emetics, prokinetics and bowel routine

# **Reconciliation** *Standard of Practice* Update

The Reconciliation Working Group of the College has completed their draft Reconciliation *Standard of Practice*. The standard has gone through member consultation as well as with external stakeholders. Currently, the standard is with government for final consultation. Once consultation is complete, the standard will come back to Council for review of feedback. # Social Media and Conflict of Interest Follow-up

Some of you may be following the media coverage around anti-diet messaging, dietitians, and conflicts of interest, as posted in the Washington Post several months ago, and on CBC's The Current earlier this week.

To manage conflicts of interest, and other ethical dilemmas, the College continues to encourage dietitians to review the resources available on our website under <u>Regulated Member Resources</u>, Practice Statements and Guidelines, as well as the *Standards of Practice* and *Code of Ethics* (available under <u>Regulatory Documents</u>).

For example, as stated in the *Standards of Practice*, Standard 7. Conflict of Interest:

Registered Dietitians will avoid real or perceived conflicts of interest in which professional integrity, professional independence or the provision of professional services could be compromised. Conflicts of interest which cannot be avoided must be disclosed and managed.

The College encourages dietitians to review these resources and contact the <u>College office</u> when questions or concerns arise.

## **Continuing Competence Program (CCP) Audit Process**

Continuing Competence Program (CCP) submissions were completed in March by all regulated members for 2023/2024. The CCP audit process has begun in April 2024.

- For any regulated members selected for **Review Audit**, you will see this selection noted in the <u>Registrant Portal</u> under "My Audits". Please note, no action is required from you unless you are contacted by the College.
- For any regulated members selected for **Document Audit**, in addition to having a record noted in your "My Audits" section online, you will also receive an email by the end of April requesting the required documentation. The College will communicate by email when requesting audit documentation.

# **Canadian Dietetic Registration Examination (CDRE)**

For all Temporary regulated members who are scheduled to complete the **May 16-17, 2024** sitting of the Canadian Dietetic Registration Examination (CDRE), the College anticipates receiving the results by late June.

## **External Survey "ACH Pediatric Project ECHO"**

The University of New Mexico Health Sciences Centre developed Project ECHO, a model aimed at training community-based and allied healthcare providers in assessing and treating various medical conditions. This model utilizes video conferencing technology to connect community providers ("spokes") with an interdisciplinary panel of experts ("hub"). ECHO clinics serve as virtual learning sessions focused on case-based learning and the dissemination of evidence-based practices.

In a bid to improve access to care for children with medical complexities, including children with global neurodevelopmental disorders, the Alberta Children's Hospital is initiating a Pediatric Project ECHO. This project aims to empower community healthcare providers to address disparities in care by offering consistent, timely, accessible, and culturally responsive services to children and families within their communities. To enhance support provided by the hospital to community healthcare providers, it's crucial to understand the perceived barriers and supports required in managing the care of children with medical complexities in Alberta.

All Dietitians, as regulated professionals, have a duty to ensure their profile information with the College is updated within 30 days of any change in the information required for the College's Register. This includes changes to your legal name, contact information (phone and email), mailing address, and employment information. You should update your profile information online by logging onto the <u>Registrant Portal</u> to complete a Profile Update.

If any information found on the <u>Public Register</u> or <u>Find a Dietitian Directory</u> is inaccurate or incomplete, please <u>contact the College office</u> to request a correction.

#### **Two-Factor-Authentication Security**

Two-Factor-Authentication is well established as an essential component of security best practices. The College of Dietitians of Alberta is committed to protecting the privacy and security of your personal information. The College's <u>Registrant Portal</u> requires Two-Factor-Authentication for each user.
